One reason is there are time limits ("statutes of limitations") for making claims. If you wait too long and the statute of limitations passes, you will be prevented

from bringing your claim.

Courts strictly follow statutes of limitations. In one case, a woman hurt in a car accident made a claim one day after the statute

of limitations passed. Even though this was a minor violation, a court dismissed her claim and she could not

**No Recovery, No Fee: How
Accident Victims Are Charged**

Many accident victims don't make a claim because they think they can't afford the legal fees. It's important to remember that all personal injury claims and worker's compensation claims are handled on a contingent fee. This means the legal fee is paid out of the recovery. If there's no recovery, there's no legal fee.

Contingent legal fees are great

because they allow any accident and work injury victim with a good case to get a lawyer's help. Without contingent fees, it would be hard for most accident victims to make a claim, especially with insurance companies and their teams of lawyers and adjusters on the other side working to lower accident payouts.

The "no recovery, no fee" method benefits accident victims by making

it easy for them to get a lawyer's help when making a claim to an insurance company. This helps even the playing field and results in much higher payments to accident victims. It also shows the lawyer's strong commitment since the lawyer gets paid only if the client recovers money.
