Winter Safety: 5 Essentials After a Crash

Protect yourself by following these five steps:

- 1. Clear the Road:** Check for injuries and call 911. If the vehicles are drivable, move them to the shoulder immediately to avoid secondary accidents on slick roads.
- 2. Stay Protected:** If your car is immobilized in traffic, stay inside. Your vehicle acts as a protective shell. Only exit when you can safely reach an area well off the pavement.
- 3. Ensure Visibility & Airflow:** Turn on hazard lights and use flares. If you must run the engine for heat, ensure your exhaust pipe is clear of snow to prevent carbon monoxide poisoning.
